What does the Fund invest in?

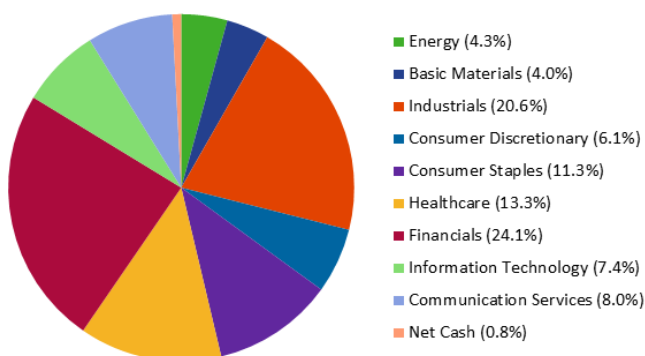

By targeting companies that pay out a low percentage of their earnings, yield stability is increased. The companies in the portfolio tend to exhibit high quality management, clean balance sheets, and strengthening competitive positions in their industry. The Fund is classified as a Global Equity Balanced Fund thus, it must invest less than 70% of its total assets in a combination of equity securities domiciled in Canada and Canadian dollar denominated fixed income securities.

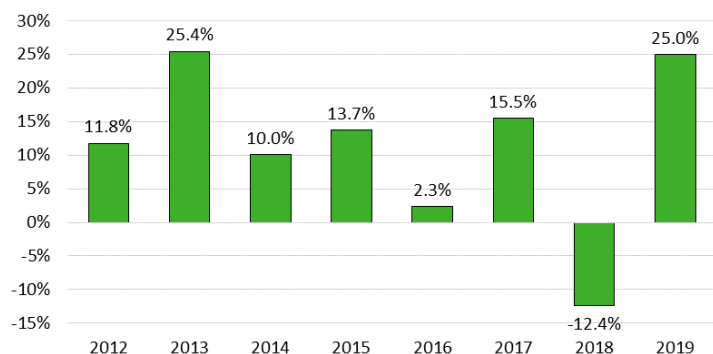

More about the trailing commission

NCM Asset Management Ltd. pays the trailing commission to your representative's firm. It is paid from the Fund's management fee and is based on the value of your investment. The rate depends on the sales charge option you choose.

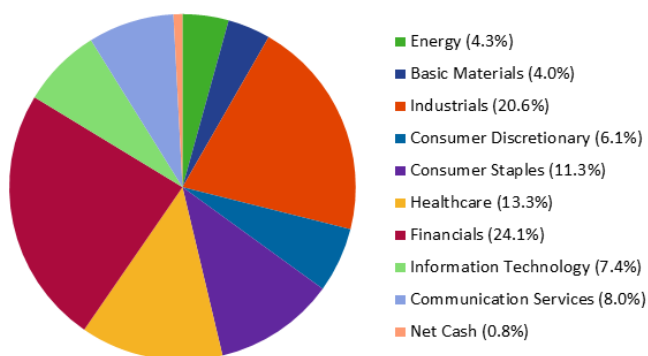

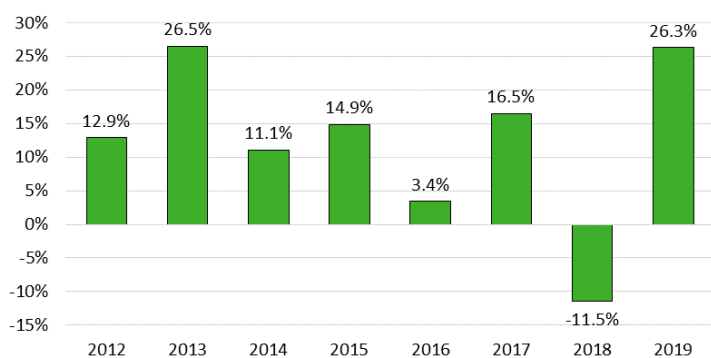

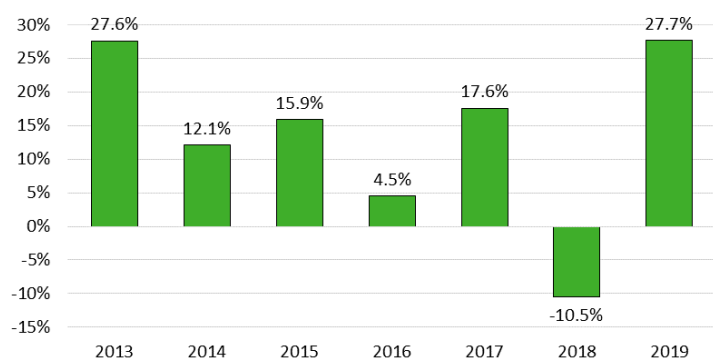

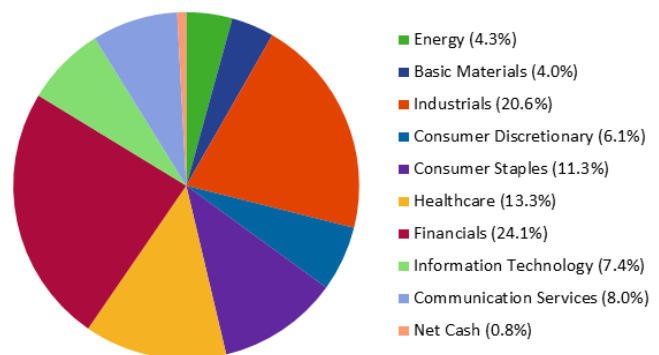

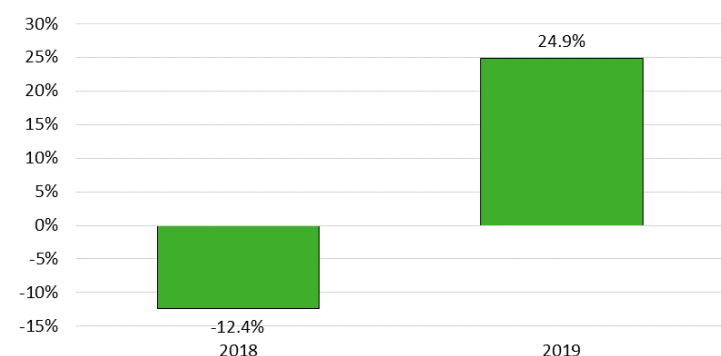

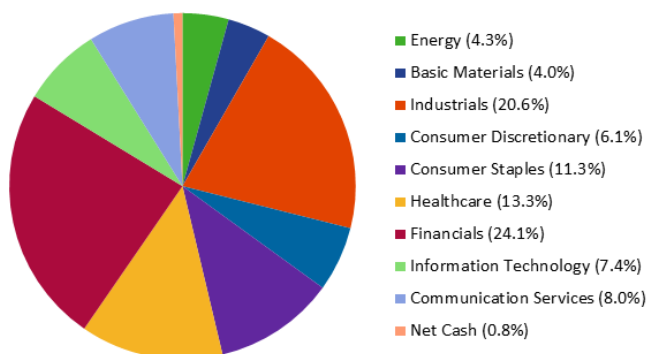

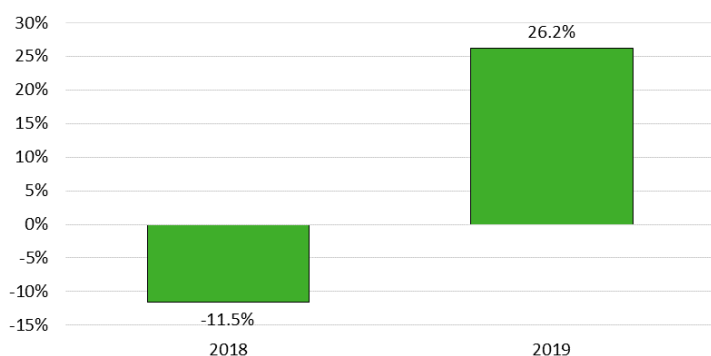
