What does the Fund invest in?			
<p>The Fund is designed to provide investors with a balance of income and long term capital appreciation by investing, directly or indirectly through investments in underlying funds, in a diversified portfolio of fixed-income securities and equity securities from anywhere in the world. It is expected that the Fund will invest primarily in underlying funds managed by the Manager or its affiliates and exchange traded funds.</p> <p>The charts below give you a snapshot of the Fund's investments on April 30, 2022. ### How risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### Risk rating

NCM Asset Management Ltd. has rated the volatility of this Fund as **low**.

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

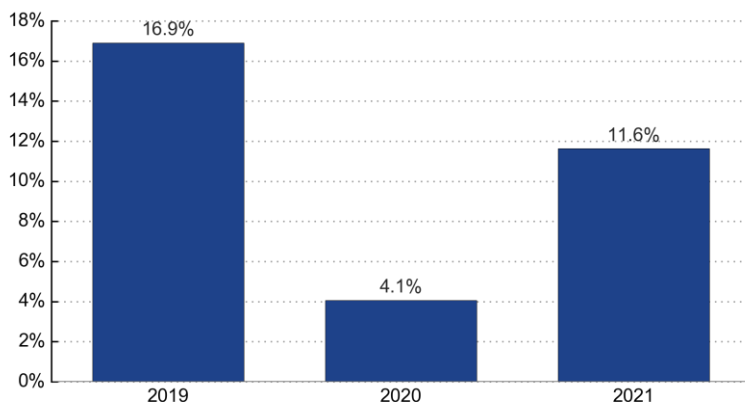
Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

### How has the Fund performed?

This section tells you how the Series F6 Units of the Fund have performed over the past 3 calendar years. Returns are after expenses have been deducted. These expenses reduce the Fund's return.

#### Year-by-Year Returns

This chart shows how the Series F6 Units of the Fund have performed over each of the past 3 calendar years. The Series decreased in value in 0 of the last 3 calendar years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



#### Best and worst 3-month returns

This table shows the best and worst returns for the Series F6 Units of the Fund in a 3-month period over the past 3 calendar years, and from January 1, 2022 to April 30, 2022. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

#### Average return

As at April 30, 2022, a person who invested \$1,000 in the Fund at its inception now has \$1,186. This works out to an annual compound return of 4.9%.

<p><b>Who is this Fund for?</b></p> <p>This Fund is suitable for investors who:</p> <ul style="list-style-type: none"> <li>• Wish to invest in a diversified portfolio of fixed-income securities and equity securities from anywhere in the world</li> <li>• Want a balance of income and long term capital appreciation</li> <li>• Are comfortable with low investment risk (i.e. are willing to accept some fluctuation in the market value of your investment)</li> <li>• Are enrolled in a fee-for-service or wrap account program</li> </ul>	<p><b>A word about tax</b></p> <p>In general, you'll have to pay income tax on any money you make on the Fund. How much you pay depends on the tax laws where you live and whether or not you hold the Fund in a registered plan such as a Registered Retirement Savings Plan, or a Tax-Free Savings Account.</p> <p>Keep in mind that if you hold your Fund in a non-registered account, distributions are included in your taxable income, whether you get them in cash or have them reinvested.</p> <p>Fund distributions that are a return of capital are not included in your taxable income, but will affect your capital gains or losses on disposition.</p>

**How much does it cost?**

The following tables show the fees and expenses you could pay to buy, own and sell Series F6 Units of the Fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

**1. Sales charges**  
No sales charges or commissions are applicable to this series of the Fund.

**2. Fund Expenses**  
You don't pay these expenses directly. They affect you because they reduce the Fund's returns. As of September 30, 2021, the Fund's expenses were 1.53% of its value. This equals \$15.30 for every \$1,000 invested.

NCM Asset Management Ltd. waived some of the Fund's expenses. If it had not done so, the MER would have been higher.

**More about the trailing commission**

There is no trailing commission paid by the Fund or the Manager to your representative's firm for Series F6 Units of the Fund.

**3. Other Fees**

You may have to pay other fees when you buy, hold, sell or switch units of the Fund.

<b>Fee</b>	<b>What you pay</b>
<b>Short-term redemption fee</b>	2% of the cost of the units you redeem within 30 days of the original date of purchase. This fee is charged by the Manager.
<b>Switch fee</b>	Your representative's firm may charge you a fee if you switch to another series of the Fund or to another Fund within the NCM Group of Funds.
<b>Fee-for-service program</b>	Series F6 Units are intended for investors who are participants in a fee-for-service or wrap account program sponsored by certain securities dealers. You pay a fee to your representative's firm to participate in such a program.

<p><b>What if I change my mind?</b></p> <p>Under securities law in some provinces and territories, you have the right to:</p> <ul style="list-style-type: none"><li>• Withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus of Fund Facts document, or</li><li>• Cancel your purchase within 48 hours after you receive confirmation of the purchase.</li></ul> <p>In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document, or financial statements contain a misrepresentation.
